<b>What?</b>	The types of personal information we collect and share depends on the product or service you have with us. <b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. <b>Affiliates</b>	<p>Companies related by common ownership and control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ DiNuzzo Tax Consulting, LLC</li> <li>▪ DiNuzzo Risk Management Solutions, LLC</li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>We do not share with nonaffiliates so that they can market to you.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or service to you.</p> <ul style="list-style-type: none"> <li>▪ <i>We do not jointly market.</i></li> </ul>
